In continuation, we have hit another bottleneck, and therefore we have again approached you and requested if you can further help and guide us. There are around 200 participants who would be preparing for this life-changing day. Aravindam will continue to support and prepare the students for their skill development program activities. All preparations shall exclusively be taken up on Saturdays and Sundays; it is when the students will solely dedicate their time and energy to practicing and enhancing their skills.

However, the bottleneck that we have hit is that preparatory classes shall run for around 6 to 7 hours each day on the weekend. The students would require actual hard work to harness their skills. We would need your support in helping us raise funds catering for the dietary requirements of the students. The details of the requirements are as mentioned below.

1. No. of Students: 200 candidates.
2. One meal for each student on Saturday and Sunday for 52 weeks
3. Total cooked and nutritional meal requirement: 20800 meals for a year.
4. Our vendor has agreed to supply the required quantity for Rs. 20 per meal.
5. The total funds required is around for 20800 meals are approx. Rs. 4,16,000/- (Rupees Four Lakh Sixteen Thousand Only).

We, Aravindam, are happy to learn about one of your heart-warming campaigns, i.e. Mid-Day Meal campaign, which helped serve thousands of meals to underprivileged students. Thoughtfully, the need for nutrition is equally important for children, and we have come up with the thought of feeding the children toiling at their study in the hot summer afternoon.
